# Warehousing Agreement QLD NSW VIC (Winter Crop)

### DISCLOSURE NOTICE

You should be aware that this agreement contains terms that affect the rights and obligations of the Customer, including terms that:

- Exclude GrainFlow's liability for consequential loss and otherwise limit GrainFlow's liability (to the extent permitted by law).
- Impose obligations on You to indemnify GrainFlow in certain circumstances where You have not complied with obligations under the agreement.
- Permit GrainFlow to provide data about You and data provided by you (including personal information) to third parties in a way that may identify You and relevant individuals.

### IMPORTANT GROWER INFORMATION

This document and the Receival and Warehousing Terms and Conditions 2024-25 (agreement available at [www.grainflow.com.au/growers](http://www.grainflow.com.au/growers)) constitute our agreement with the Grower identified below (you or your) in relation to the provision of receival, warehousing, storage and related services. By signing this document you agree to be bound by the Receival and Warehousing Standard Terms and Conditions 2024-25. This document must be completed prior to your first delivery. Capitalised terms not otherwise defined in this document have the meaning given to them in the Receival and Warehousing Standard Terms and Conditions 2024-25.

Storage is free until 30 June 2025. Any grain that has not been transferred to a participating marketer after the expiration of this period will incur a storage fee of **\$2.20** per tonne (ex GST) per month for all cereal, oilseed and pulse storage.

Grain not transferred by midnight September 30<sup>th</sup> 2025 will incur an ongoing monthly fee of **\$3.54** per tonne (ex GST) for cereal grain and for all oilseed and pulse storage.

Should you sell your warehoused grain there are several ways in which you can transfer your tickets:

**HALOXYFOP:** GrainFlow sites will not be accepting canola treated with haloxyfop and growers will be asked to provide a declaration to this effect when tendering canola for delivery.
